Dear Senators Murray and Casey,

The undersigned organizations write to express strong support for the *Protect Access to Birth Control Act*, your legislation to strike the two interim final rules (IFRs) published on October 13, 2017 that roll back the Affordable Care Act's (ACA) birth control coverage which has ensured access to birth control coverage for more than 62 million women around the country.

The Trump administration's IFRs allow virtually any employer or university to refuse to cover contraception in their group health plans on the basis of religious or moral objection. Individuals would also be able to request coverage that does not include contraception, and issuers would be permitted to opt-out of providing group or individual coverage on the basis of any religious or moral objection.

These IFRs are particularly outrageous given that birth control is basic healthcare for millions around the country. The nonpartisan Institute of Medicine (IOM) recommended that birth control be covered as women's preventive care because it is fundamental to improving not only women's health, but the health of their families as well and this recommendation was reaffirmed as recently as last year. Nearly nine in 10 women of reproductive age will use contraception at some point in their lives, whether for family planning or other medical reasons like treating endometriosis. The rate of unintended pregnancy is at its lowest in 30 years¹, and the rate of pregnancy among teens is at a historic low ² because of expanded access to birth control and sex education. This access furthers equality, enabling women to pursue professional and educational opportunities.

The ACA's birth control benefit has also improved women's economic security. The decision whether or when to have children is one of the most important economic decisions a woman will make in her lifetime, and access to birth control coverage is critical to this planning. Furthermore, the benefit saved women an estimated \$1.4 billion on birth control pills in its first year alone.³

Like you, we are deeply concerned that as a result of these IFRs some people will no longer be guaranteed birth control coverage under the ACA. We appreciate your efforts to strike these harmful and discriminatory rules and we look forward to working with you and your colleagues to ensure that access to birth control is a reality for those who rely on it.
